This committee shall be known as the Bylaws and Revisions Ad Hoc Committee. This committee is an Ad Hoc committee of ASI.

2. Purpose and Duties

The Bylaws and Revisions Ad Hoc Committee will be dedicated to looking over the ASI current bylaws and structure of the ASI Board of Directors. The Purpose and duties of the Bylaws and Revisions committee shall be to:

Review the current Bylaws of Associated Students Inc., CSU East Bay Revaluating the current Board of Directors structure and find improvements Ensure that all possible revisions will benefit the students and the Auxiliary Make recommendations to the Board of Directors about the Bylaws

3. Membership

The Vice President of University Affair will chair the Bylaws and Revisions Ad Hoc Committee.

Additionally, voting members of the Bylaws and Revisions Ad Hoc Committee will include:
